Mrs. Richmond moved to accept the minutes of March 25, 1993, as amended, seconded by Mr. Glennon and unanimously carried.

Mrs. Carr moved to approve warrant, page 2163, in the amount of \$98,272.43, seconded by Mrs. Richmond and unanimously carried.

Mrs. Richmond moved to approve warrant, page 2164, in the amount of \$61,414.28, seconded by Mr. Glennon and unanimously carried.

Mr. Glennon moved to approve warrant, page 2165, in the amount of \$1,104.00, seconded by Mrs. Carr and unanimously carried.

#### COMMUNICATIONS

A note was received from the family of Edgar Gildersleeve thanking the library and the Board of Trustees for the "beautiful flowers" after the passing of Edgar Gildersleeve.

#### DIRECTOR'S REPORT

The Director's report was mailed to the Board prior to the meeting for their review.

The library received a check for \$135.57 for royalties from the sales of the Video Hand Saver.

Mrs. Carr moved to have a six foot chain link fence installed across the front of the adjacent property on June Avenue and to remove the undergrowth, at a total cost of under \$2500.00, seconded by Mrs. Richmond and unanimously carried.

ACCEPTANCE OF RESULTS OF LIBRARY BUDGET VOTE & ELECTION OF TRUSTEE Mr. Glennon moved to accept the library budget vote for 1993/94 and the re-election of Trustee Jennifer Richmond for a five year term, seconded by Mrs. Carr and unanimously carried. (see attached page)

#### PERSONNEL

The Director proudly informed the Board that Barbara Johnson, a Reference Librarian, has been appointed Village Historian.

Mrs. Richmond moved to allow that Barbara Johnson can devote four hours of her work week to perform duties as Village Historian. Also, that James Olney be taken off the librarian trainee Civil Service list, when it is released, so that he can work over 17 hours per week on a regular basis, seconded by Mr. Glennon and unanimously carried.

The Director requested an interpretation of the family health insurance policy from the Board and the library attorney. It was agreed that "past practice prevails."

#### BUILDING PROGRAM

The Board agreed to continue with their plans to find a site for a central library building.

The Board discussed how to proceed with negotiations with the owner of a possible building site. Various possible sites were reviewed and discussed.

Mrs. Carr moved that the Director is hereby authorized to execute all other documents on behalf of the Trustees necessary to complete the subdivision known as Gildersleeve Estates, seconded by Mrs. Richmond and unanimously carried.

#### OTHER

Americans with Disabilities Act Policy (ADA)

Mr. Todd Harvey, of Beatty, Harvey Asssociates, has inspected and evaluated the library on its accessibility for patrons with disabilities so that the building will be in accordance with the ADA regulations. His report will be received in several weeks.
