A letter was received from Clarence J. Sundram, Chairman, State of New York, Commission on Quality of Care for the Mentally Disabled, informing the library that the Northport library "has been selected by random sample" to be part of a study "to evaluate ADA accessibility in businesses."

DIRECTOR'S REPORT

The Director reviewed the 1994/95 budget vote and the election of Elizabeth McGrail to the position of Trustee for three years and to the re-election of C. Annette Carr as Trustee for a term of five years; the records and files have been put in proper order; Fran Burton was thanked for her good as well as hard work; the Director thanked each of the Trustees for working so hard to get out the vote.

The Director reported that the grounds look wonderful; that a more sophisticated and more efficient watercooler has been installed in Northport that drains into the plumbing system; there was less money spent on fuel oil because of the warm winter; the striping on the outside curb and steps has been completed to avoid accidents; the Laptime Collection and Pathfinder brochures were distributed to the Board.

The Director commented that Fran Romer had reported that Christine Moore, student intern from C. W. Post, who wrote the Pathfinder, has been very productive; the library is organizing a traditional Friends of the Library group; letters are to be sent to all "Friends of Our Future" to inform them and also to invite them to a reception at the organizational meeting of the Traditional Friends Group in May; informed the Board that New York State is cutting back on monies to libraries.
