RESOLUTION

Mrs. McKay moved to adopt the following resolution: At the meeting of the Board of Trustees of the Northport-East Northport Public Library held on Thursday, July 15, 1999 the following resolution was offered: "Be it resolved the Board of Trustees of the Northport-East Northport Public Library does hereby elect to authorize a Staff Retirement Award for Service for all eligible employees who reach age 60 and have completed 10 years of full or part time continuous service at the Northport-Eas: Northport Library by September 1, 1999. award offering is in the amount of \$800 per each completed year of service as of September 1, 1999 up to a maximum of \$25,000 for full time eligibles and \$10,000 for part time eligibles. Effective date of retirement must be set during the 90 day period of October 1 through December 31, 1999 and the Employee Participation/Declination Certification must be submitted to the Library Director no later than September 1, 1999." Seconded by Mrs. McGrail and unanimously carried.
