6) DIRECTOR'S REPORT

The Director's Report was given orally. In addition to the packet mailed in advance the report contained the following library service area highlights.

Administration - Our Annual Department Head Luncheon provided a collegial atmosphere for our team leaders to share their top contributions to library service during the past year. Each received a copy of THE DAILY CARROT PRINCIPLE: 315 WAYS TO ENHANCE YOUR CAREER AND LIFE.

An insurance claim has been filed to recoup any compensation for the water-main break. A two day virtual ALA Conference webinar was offered with 32 librarians participating in one or more of the various topics.

Buildings & Grounds - The emergency water main repair was complicated by the proximity to the electrical and gas supply lines. Additionally, a hidden steel beam and an abandoned pipe impeded the installation of a new supply line.

A LIPA brownout during this heat wave caused damage to our air conditioning compressor in the main Reading Room, landscaping sprinkler system and the electric Courtyard sliding door.

Circulation - Patron self-registration for a temporary library card includes a GIS library locator map to help new residents identify which library district they belong to. Their temporary barcode will give them remote access to all Live-brary.com resources.

Community Services - The Outdoor Concert in the Library Courtyard drew 170 to the first one, Young Rebel Goombas. Our outreach to veterans continue with 2 sessions of "Health Services for Veterans" drawing 34 attendees.

Patron requests have brought back café mugs for purchase with a new design and color.

East Northport - Let's Talk: Friendly English Conversation Group will meet 2 Fridays per month starting in September.

Network & Systems - A self-service scanning station with a touch screen for easy navigation has been installed in Northport. A book-edge design protects the spine of book bindings from damage and software provides PDF files that may be searched by keywords.
